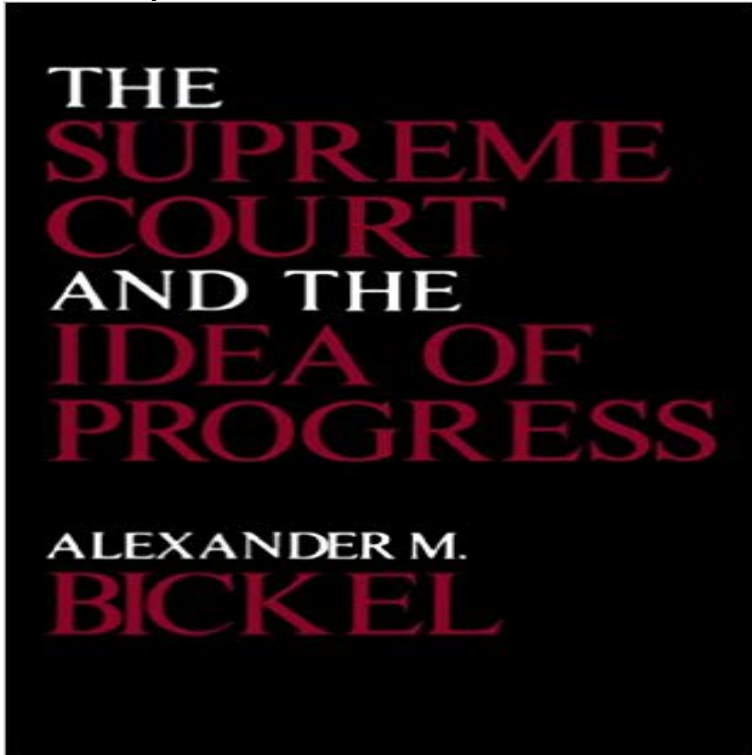


The Supreme Court and the Idea of Progress
